Bloom Township Families, Community Members, and Stakeholders:

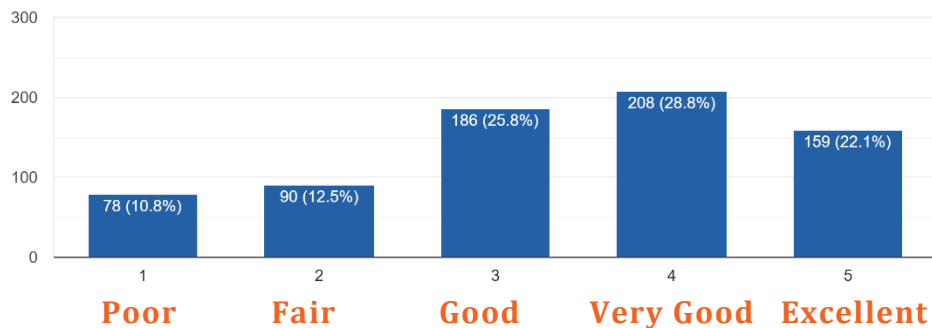

We hope this summary is helpful for you.

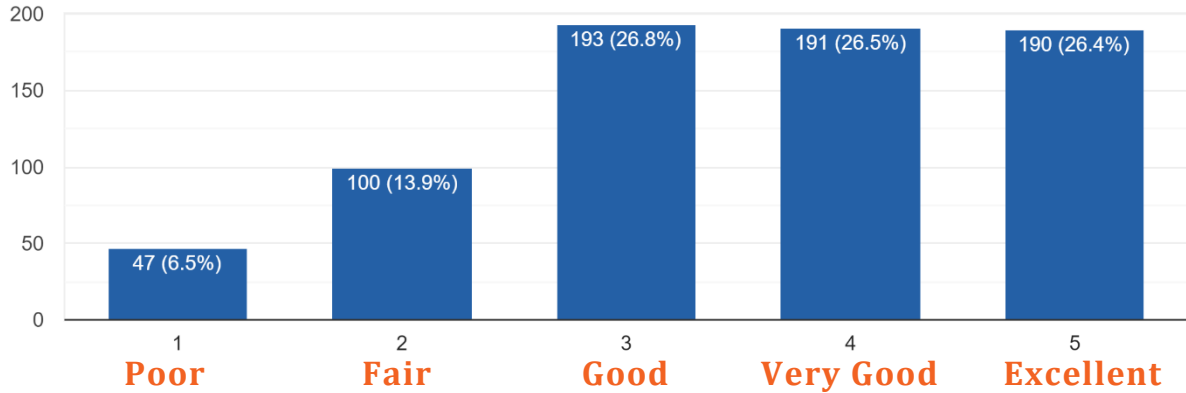

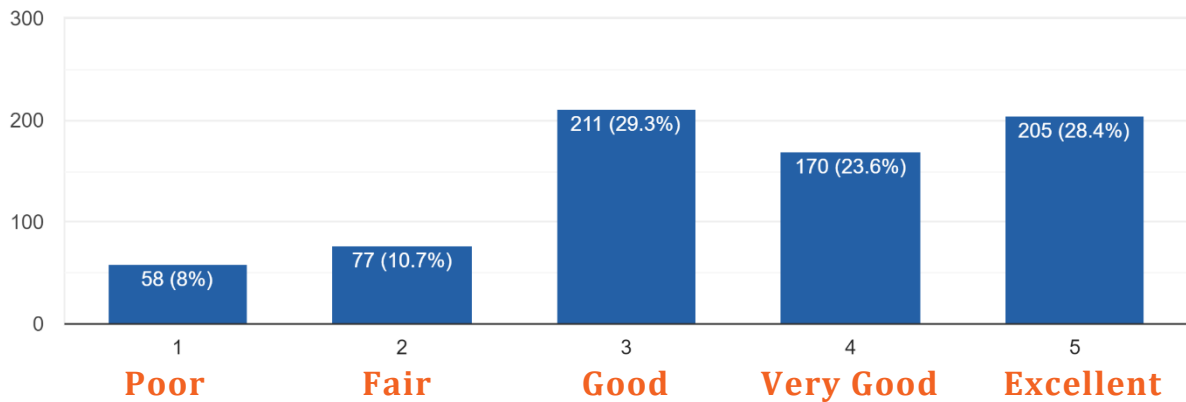

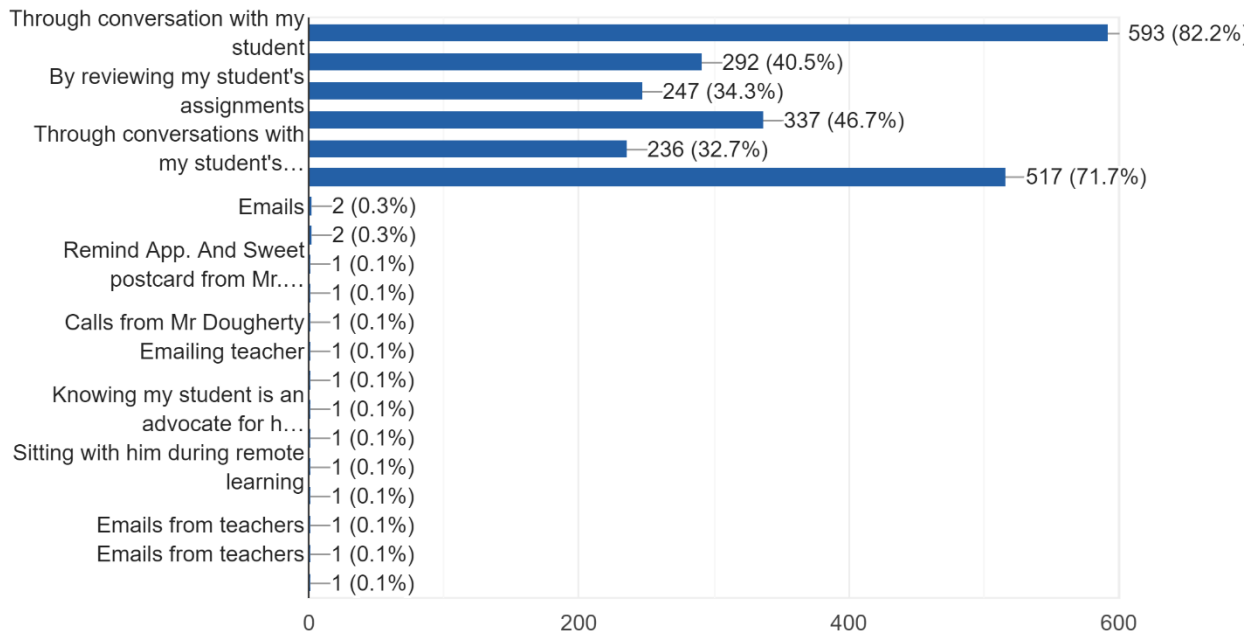

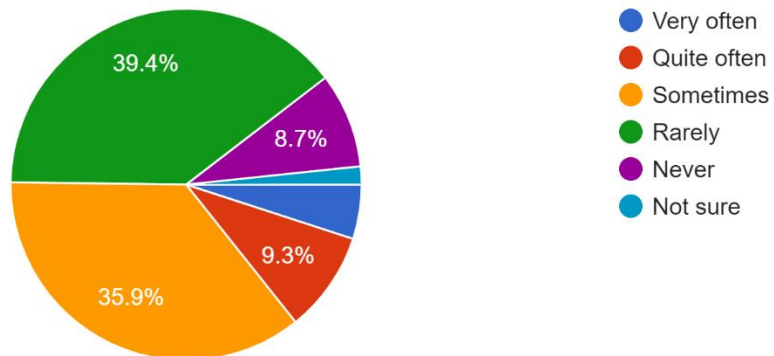


HOW HAVE YOU BEEN ABLE TO LEARN ABOUT YOUR STUDENT'S REMOTE LEARNING EXPERIENCE?



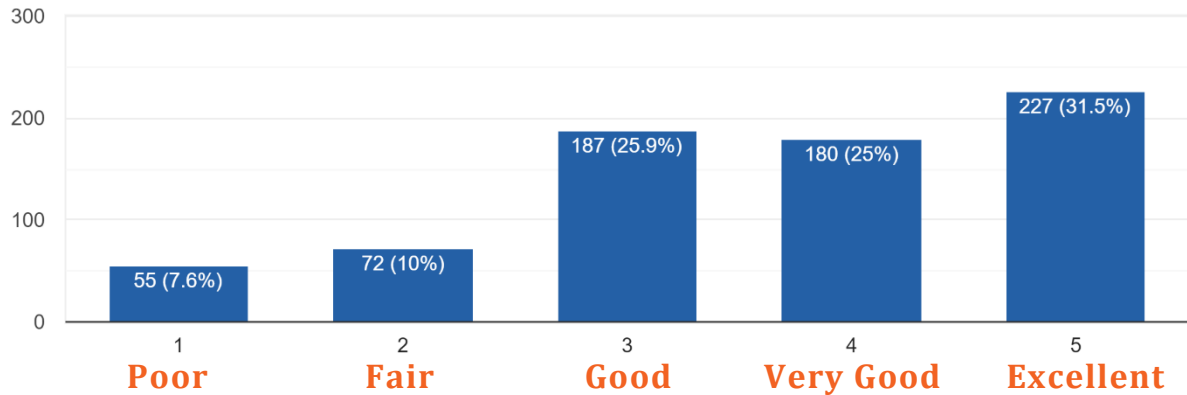

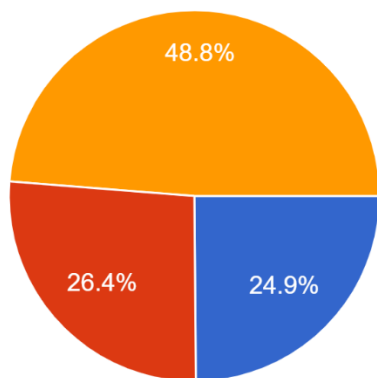


ON A SCALE FROM 1 TO 5, HOW ARE YOU HANDLING REMOTE LEARNING AS A PARENT?
